Eligibility Criteria

The following vendors are eligible to quote:-

- 1. Indian Manufacturers (Must self-certify)
- 2. Indian agents / distributors / stockists of Foreign principals (Must attach specific authorization letter from foreign principal to quote for running contract to KVASU)
- 3. Dealer for Indian Manufacturer (Must attach specific authorization letter from manufacturer to quote for running contract to KVASU).
- 4. The following documents are to be compulsorily attached along with the bid failing which the bid will be rejected:
 - a. Copies of three concluded Rate/running contract from ICAR/ICMR/CSIR/ Universities or any other govt. organization (for the period 2019-20, 2020-21 & or 2021-22) (This criterion is not mandatory for selection of suppliers for high purity gases and suppliers who are established after 1.1.2017, upon production of proof for the same)
 - b. Copies of 3 purchase orders received valuing Rs. 1,00,000/- or more OR 5 purchase orders valuing Rs. 50,000 or more in each case from any CSIR/ICAR/ICMR/ Universities or any govt. Research Institutes (for the period above mentioned) (This criteria is not mandatory for selection of suppliers for high purity gases and suppliers who are established after 1.1.2017, upon production of proof for the same)
 - c. Copy of the audited balance sheet of the Vendor for the year 2019-20 indicating the annual turnover.
 - d. A certificate indicating, the name, address, fax number, email address of the Distributor, who is going to supply the material.
 - e. A certificate regarding the discount extended by the dealer. (This must be on the dealer's letter head).
- 6. The bidders should clearly indicate, for which category of materials they are quoting for.

Terms & Conditions

- The Tenderers are requested to submit their offer in their own letter head neatly typewritten without any cutting or over writing in the prescribed format (Annexure C) online.
- 2. The Tenderers shall have to **indicate clearly the brand of the product(s)** for which they will submit the running contract offer.
- 3. This Institute is interested to enter into running contract with only reputed manufacturers or with their authorized dealers/distributors. Hence the tenderers are advised to attach the current year's authorization letter along with their offer (as per Annexure-A) to prove their credentials or bonafides with regard to their as well-established manufacturer or authorized dealer in terms of quality/reputation of their products in scientific community. Please note that the authorization letter by principal / manufacturer should exclusively addressed to Director Academic and Research, KVASU, Pookode, indicating that they are authorized to quote/sell the product of their principal otherwise offer will not be considered for evaluation.
- 4. The Tenderers should submit valid documentary proof of GST registration number and the details of Income Tax registration (PAN).
- Tenders will be opened on 4th July, 2022 at 11.00 AM at E-procurement Cell, COVAS, Pookode, in presence of the Tenderers who wish to be present. If the tender opening date is declared as holiday in KVASU, they will be opened on the next working day.
- 6. Please do submit the **list of customers** (Government/Private research laboratories/Institutes of repute including CSIR/ICMR/ICAR laboratories/institutes/universities where rate/running Contract for these categories have been finalized with your firm). In the customer list the name of contact person, designation, telephone, fax and e-mail numbers must be given.
- 7. Please do submit the photocopies of rate/running contract for the categories of which tenderer is applying during the last three years with your customers as mentioned at Sl. No. 7, for our reference.
- 8. The university will prefer to enter into running contract with the manufacturers who can supply the materials directly to us from their depot or warehouse or else supply the material through their dealer within the delivery schedule as per KVASU requirement.
- 9. The firms entering into contract should be willing to supply the items to any station and unit under the university (annexure H) at the rate mentioned in the catalogue/ price list failing which will be treated as breach of contract and the firm/dealer is liable to be black listed by the University.

- 11. Quote the maximum discount on the list price as applicable to Government/Public Funded Research Institutes. Discount must be indicated in words as well as in figures. Current price list is to be valid for one year from the date of acceptance of tender failing which the offer will not be considered. Price list must be stamped and signed with date by the Tenderer in the hard copy submitted.
- 12. (a). The offer should be based on free delivery at various KVASU stations/units(Annexure H).
 - **(b).** A delivery time of 20 days from date of Purchase Order will be given for stock items and 45 days for all other items.
- 13. The Tenderer must agree for immediate free replacement in case any discrepancy is found with regard to quality/quantity of the material to be supplied by them under this running contract.
- 14. KVASU is exempted from payment of Central Excise Duty under Government Notification No. 10/97-Central Excise dated 01st March, 1997 and exempted from payment of Customs Duty under Government Notification No. 51/96-Customs dated 23rd July, 1996. Essentiality certificate for claiming concessional GST in respect of goods procured by a Public Funded Research Institution for research purpose only in accordance with the Notification No. 45/2017-Central Tax (Rate) and Notification No. 47/2017-Integrated Tax (Rate) 2017 Notification No..45/2017 Union Territory (Rate) dt 14.11.2017, Notification No..47/2017- Integrated Tax(Rate) dt.14.11.2017, Notification No..10/2018-Integrated Tax(Rate) dt 25.01.2018, Notification No.09/2018 -Union Territory (Rate) dt.25.01.2018 and Notification No.09/2018 -Central Tax (Rate) dt.25.01.2018 of Ministry of Finance (Department of Revenue), Government of India shall be issued. The Tenderers are advised to go through these Notifications thoroughly and mention clearly regarding the GST/Excise Duty/Custom Duty in their offer.
- 15. Payment will be made only after the receipt of material in our stores in good condition. No other payment term will be acceptable to us.
- There will be no separate packing and forwarding charges payable for supply against this Running contract.
- 17. During the running contract period, any time bound special offer introduced by manufacturer/supplier must be offered to KVASU also and same should be intimated in advance and the same shall be mentioned in the invoice/bill. However, KVASU will have the right to avail the offer or not.
- 18. Tenderer will have to supply the ordered material under this running contract within 20 days of placement of purchase order in full quantity, part supplies will not be accepted otherwise order may be cancelled and further action as deemed proper may also be taken.
- 19. The rate and term of running contract would also be applicable for the purchase made by the Scientists/Students of KVASU on cash/credit basis and hence, the firms or their agents are not allowed to charge higher prices than those approved under the R/C

- Late, delayed incomplete, unsigned offers and offers without EMD and tender fee will not be considered at all.
- 21. Compliance with National/International standards, if any, should be specified.
- 22. Parallel running contract for similar items can be placed at any time during the period of running contract with one or more parties.
- 23. The University holds the right to terminate the running contract with any firm without any notice, in case the performance of the tenderer is found consistently unsatisfactory or due to the serious lapse on the part of the tenderer.
- 24. The Director of Academic and Research, KVASU reserves the right to accept or reject any offer in part or in full without assigning any reasons thereof.
- 25. Jurisdiction: All question, disputes or differences under, out of or in connection with the contract, if concluded shall be subject to the exclusive jurisdiction of the Court within the local limits of whole jurisdiction the place from which the acceptance of tender is issued is situated.
- 26. **Arbitration clause**: The Purchaser and the supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.
- a) If, after thirty (30) days from the commencement of such informal negotiations, the Purchaser and the Supplier have been unable to resolve amicably a Contract dispute, either party may require that the dispute be referred for resolution to the formal mechanisms as specified below. These mechanisms may include, but are not limited to, conciliation mediated by a third party, adjudication in an agreed national and international arbitration.
- In case of Dispute or difference arising between the Purchaser and a supplier relating to any matter arising out of or connected with this agreement, such disputes or difference shall be settled in accordance with the Arbitration and Conciliation Act, 1996. The dispute shall be referred to the Vice Chancellor and if he is unable or unwilling to act, to the sole arbitration of some other person appointed by him willing to act as arbitrator. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to this contract / subsequent orders based on contract.
 - 27. Extension of contract: The Running contract with successful running contract holders may be extended for another period of three months based on fresh price lists / catalogues in EXCEL format in CD based on satisfactory performance during the first year.
 - All prices should be in INR only. Running contract prices in foreign currency will not be considered.
 - 29. An EMD of Rs.5000.00 (Rupees Five thousand only) by online payment
 - 30. The tender document fee of Rs. 1500/- (Rupees One thousand five hundred only) + 18 % GST[GST to be paid by the bidder directly and submit proof along with tender)] by online payment

- 31. Selected firms should execute an agreement or written contract with the Kerala Veterinary and Animal Sciences University and a performance security deposit as decided by the University.
- 32. The Tenderers will have to confirm in writing in their offer that all the terms and conditions mentioned above are acceptable to them.
- 33. The selected bidders are bound to supply all the items in the catalogue for which the orders are placed, unless the manufacturer withdraw/ discontinue the product. If such selected bidder fails to supply the items as per the agreement, the University reserves the right to select the next bidder from the list who is willing to supply the items. The defaulters may be blacklisted and may be prohibited from participating in any future running contracts of the University.
- 34. Conditional prices based on buying or assuming certain volumes should not be quoted.
- 35. Since the usage of a particular brand may have led to standardization of experiments and its results may have led to certain publication and patents, KVASU reserves the right to select a firm for running contract based on its continuous usage and uniform results and therefore reserves the right not to go only by the price criteria of a particular item.
- 36. Price list and all the annexures (except annexure H) should be submitted by the participating firms.

- 1.3 If it is discovered that we have contravened the above conditions, then without prejudice to any other action which might be taken against us, it shall be lawful for the purchaser to (a) revise the price at any stage so as to bring it in conformity or (b) to terminate the contract and purchase the items of stores at the risk and cost to us and loss recovered from the vendor.
- 1.4 During the tenure of the Running Contract, the benefits of any promotional offers by the manufacturers will also be passed on to Purchase officer and Director, Academic and Research, KVASU, Pookode
