Competitive e-tenders (online bids) are invited by the **The Co-ordinator**, **Bioscience Research and Training Centre**, **Thonnakkal**, **Thiruvananthapuram**, **Kerala** for and on behalf of the Vice Chancellor of KVASU from eligible reputed registered firms/manufacturers/authorized dealers through e-procurement portal of Government of Kerala (https://www.etenders.kerala.gov.in) for the **Supply of a Real Time PCR System** as detailed in Annexure-I & III, for scientific research to the Bioscience Research and Training Centre, Thonnakkal, Thiruvananthapuram, Kerala under State Plan 2020-21 project "Laboratory at BRTC".

- 4. Last date for tender submission: 06.07.2022 (11.00 am)
- 5. Technical bid opening date: 07.07.2022 (11.00 am)
- 6. Place of opening of e-tender: E procurement cell, College of Veterinary and Animal Sciences, Mannuthy.
- 7. Tender forms are not being sold separately and the same can be downloaded from e-tender website (https://www.etenders.kerala.gov.in)
- 8. Tender fee: **Rs. 1860/- (Rupees One Thousand Eight Hundred and Sixty only)** to be submitted online through e-tender website + 18% GST (**Rs. 335/-Rupees Three hundred and Thirty five only**) [GST to be paid by the bidder directly though GST Website (https://payment.gst.gov.in/payment/) and submit proof (Challan) along with tender]
- 9. An Earnest Money Deposit (EMD): Rs. 30,975/- (Rupees Thirty thousand nine hundred and seventy five only) should be paid online.
- 10. (a) Micro and small Enterprises if registered with any government bodies specified by Ministry of Micro, Small & Medium Enterprises (M/o MSME) with valid certificate duly issued by GOI are exempted for submitting the tender fee and earnest money deposit (EMD). It will be applicable for those bidders who shall produce their own goods or provide their own services, and not applicable for trading purpose. <u>No entrepreneur or memorandum of application form is acceptable.</u>

(b) Other Firms, registered with MSME / NSIC with valid certificate duly issued by GOI are also exempted for submitting EMD. <u>No other type of certificate is acceptable</u>.

(c) The exemption and relaxation in EMD is subject to the validity & acceptance of their registration certificate on the date of opening of tender All the documents submitted should be duly signed and certified by authorised signatory.

- 11. Tender submitted through e-Mail or Fax will not be considered.
- 12. In case the Manufacturers / Indian Companies have customs bonded ware house in India, then the offer should not include Customs duty and other levies. The institute can issue Certificate of Registration with Department of Scientific and Industrial Research, Govt of India for availing customs duty/excise exemption.
