





Late tenders will not be accepted. # Terms and conditions

- 1. The tender should be addressed to the officer mentioned below in a sealed cover with the tender notice number and name of work duly super scribed on the cover.
- 2. The tender should be in the prescribed form which can be obtained from the officer mentioned in the tender notification on payment of the price noted therein. The cost of tender forms once paid will not be refunded. Tenders which are not in the prescribed from are liable to be rejected. The rates quoted should be only in Indian currency. Tenders in any other currency are liable to rejection.
- 3. Tenders should be submitted along with an EMD of Rs.2,500/-(Rupees Two Thousand and Five Hundred only) by way of crossed DD drawn in favour of "The Dean, VergheseKurien Institute of Dairy and Food Technology, Mannuthy" payable at SBI, Ollukkara. No interest will be paid for the EMD deposited.
- 4 a) Every tenderer who has not registered his name with the State Government (Stores Purchase Department), should send along with his tender, an earnest money of one percent of the total cost of the work tendered for (rounded to the nearest rupee). The amount may be paid by Demand Drafts (crossed) on the local branch of State Bank of India drawn in favour of "Dean, VergheseKurien Institute of Dairy and Food Technology, Mannuthy, Thrissur-680651" payable at SBI, Ollukkara. Cheques will not be accepted. The earnest money of unsuccessful tenderers will be returned as soon as possible after the tenders are settled; but that of the successful tenderers will be adjusted towards the security that will have to be deposited for the satisfactory fulfillment of the contract. No interest will be paid for the earnest money deposited.
- b) Tenderers whose names are registered with Government (Stores Purchase Department) are generally exempted from furnishing earnest money for such articles for which they have registered their names. If they tender for stores other than those for which they have registered their names, they will have to furnish earned money as in the case of unregistered *firms*.
