Applications are invited for the engagement of Senior Research Fellow under the ICAR-NASF project entitled “Development of small molecular weight bioactives and polysaccharides from marine and coastal bivalves to develop prospective nutraceutical products”

Details of vacancies: Senior Research Fellow (SRF): 01

Eligibility criteria:

Essential: Master’s degree in relevant subject (Veterinary Pharmacology and Toxicology/ Veterinary Biochemistry/ Animal Biotechnology/ Pharmacology or any subject relevant to the project) with 4 years/ 5 years of Bachelor’s degree. Candidates having post-graduate degree in Basic Sciences with 3 years Bachelor’s degree and 2 years Master’s degree should have NET qualification and 2 years of research experience as mentioned in OM No. Edn./6/27i2014/HRD dated 13th July, 2015, OM No. Agril. Edn. 6/27/2014-HRD 9th October, 2015 of the Council and OM SR/S9/Z-09/2018 of DST dated 30th January, 2019.

Desirable:

1. Evidence of research experience in cell culture works (animal/human cell lines), western blot, real time PCR, animal experimentation etc. relevant to the project will be given preference
2. Publications in NAAS/ UGC approved journals of repute.
3. Knowledge in computer applications, data organization/ management/ report preparation/ writing, power point presentation etc.

Nature of the work/ duties: The candidate has to work in cell culture laboratory performing cell based and molecular assays. Work also involves laboratory animal experimentation.

Age Limit: 35 years for men and 40 years for women as on last date of application.

Emoluments: Rs: 31,000/- per month + HRA for the 1st and 2nd year and Rs: 35,000/- per month +HRA for the 3rd year. House Rent Allowance (HRA) will be provided as per the existing rules in vogue.

Period of appointment: 3 years

Selection process: Suitably qualified candidates may e-mail the application along with all the supporting documents and research publications as a **single pdf file** in the prescribed format (Annexure- I) **on or before November 11th, 2022** to **bibujohn@kvasu.ac.in**

Application and supporting documents indifferent pdf files will summarily be rejected. The Advertisement number along with the position for which the candidate is applying should be mentioned in the subject part of the e-mail.

Applications which are not in the prescribed format will summarily be rejected.

Applicants will be short listed for the selection interview. The date, time and venue of interview will be intimated through e-mail. Selection of suitable candidates will be made based on eligibility criteria and performance in the selection interview.

Other terms and conditions:

The candidate must bring all the original certificates including experience certificate in original with them for the selection interview. Xerox copy of the certificates and complete research articles(s) mentioned under eligibility criteria has to be produced at the time of selection interview. No TA/DA will be paid to the applicants for appearing in the interview. The appointments will purely be time-bound, on contractual basis of non-regular nature and co-terminus with the project. The University or institute will hold no responsibility for payment of emoluments/ regular employment after termination of the project. Notwithstanding the duration of the scheme, the engagement of SRF can be discontinued owing to administrative reasons at any time by issue of one month's notice or one month's emoluments in lieu thereof. Non-maintenance of the discipline or failure to perform the duties assigned will make the SRF liable for termination. Other than the above mentioned, SRF appointed should complete their period of appointment. The SRF may leave the assignment, for genuine reasons with the concurrence of PI, by giving one month's notice. At the end of the contract period, the SRF will have no right to claim any employment or engagement in the ICAR/ KVASU. The incumbent shall not have any claim for regular appointment under ICAR/ University. Concealing of facts or canvassing in any form shall lead to disqualification of the candidature or termination even after appointment. The timely guidelines issued for SRFs engaged under the ICAR-NASF schemes will be followed.
