**LIMITED TENDER NOTICE**

Sealed Limited Tenders addressed to the Associate Professor and Head, Cattle Breeding Farm, Thumburmuzhy, Konnakuzhy P.O., Thrissur—680 721 are invited for the supply of **Paddy Straw**. The envelopes containing the tender should bear the superscription “**Limited Tender for the Supply of Paddy Straw**”. The last date of receipt of the tenders is **05/12/2022, 11:00 a.m, and it will be opened at 12 pm on the same day** in the presence of tenderers or the authorized representatives of the firms at the chamber of Associate Professor and Head. If any bandh/strike/unexpected holiday occurs on the date fixed for the opening of tender, the tenders will be opened at the same time on the next working day. Further details, if any, can be had from the office of the undersigned during working hours.

**TERMS AND CONDITIONS**

1. Those who submit the tenders should enclose with the tender EMD by way of DD drawn in favour of the Associate Professor and Head, Cattle Breeding Farm, Thumburmuzhy, Konnakuzhy P.O, Thrissur-680721 payable at State Bank of India, Chalakudy Branch, Thrissur. The details are given below.

2. Firms who are exempted from payment of EMD should furnish attested copy of the currently valid certificate from the Store Purchase Department, Government of Kerala. The earnest money of the unsuccessful tenderers will be returned within a period of one month after the tenders are settled. But that of the successful tenderer will be adjusted towards the security that will have to be deposited for the satisfactory fulfillment of the contract.
3. The rates quoted should be only in Indian Currency. We are exempted from the payment of customs and excise duty for our procurements and hence prices quoted should be exclusive of these. The prices quoted should be inclusive of all taxes, duties,

cesses, unloading and stacking at the farm etc. which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.

4. Withdrawal of the tender after its acceptance or failure to supply the item during the specified period will entail cancellation of the tender and purchase will be effected from elsewhere at the expense of the contractor. Purchase order will be placed depending upon the actual requirement and storage capacity. The successful bidder should supply the item at Cattle Breeding Farm, Thumburmuzhy within a week from the date of supply order. Otherwise the item will be purchased locally or elsewhere and any loss incurred thereby will be payable by the defaulter. In such events the University reserves the right to remove the defaulter's name from the list of Kerala Veterinary and Animal Sciences University suppliers permanently or for a specified period.
5. The item should be in good condition and moisture percent less than 12% and the payments will be made within a reasonable time, say 30 days from the data of receipt of goods in good condition.
6. The quoted price shall be valid for 1 year from the date of confirmation of the tender.
7. The successful bidder on confirmation of the tender will have to furnish a Performance Security of Rs. 10,000/- and execute an agreement in Kerala Stamp paper worth Rs. 200/-. Performance Security in the form of cash/Demand Draft in favour of the Associate Professor & Head, Cattle Breeding Farm, Thumburmuzhy payable at State Bank of India, Chalakudy has to be furnished. Performance Security is to be furnished within 15 days of fixing the tender. The Performance Security will be released after 1 year provided if the contractor has no pending liabilities.
8. In case when the successful tenderer fails to fulfil the contract, the tender will be offered to the next lowest bidder.
9. The Associate Professor and Head , Cattle Breeding Farm, Thumburmuzhy reserves the right to reject any tender without assigning any reason thereof.
10. Late tenders and tenders without EMD will be summarily rejected. All rules pertaining to Govt. Tenders will be applicable to this tender also.
11. **The tenders should be in the prescribed form which can be obtained from the officer mentioned below on payment of the price which is mentioned above. The tender forms can also be downloaded from the University website [www.kvasu.ac.in](http://www.kvasu.ac.in).** In such case the tenderer should enclose a receipt for cash for Rs. 448/- ( 400+12% GST) as cost of tender form, along with the tender being submitted in addition to EMD. Duplicate copies of tender forms will also be issued at the rate specified. The cost of tender forms once paid will not be refunded. Tenders which are not in the prescribed form are liable to be rejected. The rates quoted should be only in Indian currency. Tenders in any other currency are liable to rejection.
