## <u>ORDER</u>

As per the ref. 1<sup>st</sup> cited, the University Grants Commission directed to constitute University Students Grievance Redressal Committee (USGRC) to consider grievances unresolved by one or more Collegiate/ Departmental/ Institutional Students Grievance Redressal Committee and each USGRC may take up grievances arising from colleges/ departments/ Institutions, on the basis of the jurisdiction assigned to it by the Vice Chancellor. Moreover, Para 315(14), Paras 373 to 377 under Chapter XX of KVASU First Statute-2014 deals with Board for Adjudication of Students Grievances. After examining the matter in detail, a proposal placed before the meeting of Board of Management in its 73<sup>rd</sup> meeting held on 18-11- 2021. The proposal was approved.

University Students Grievance Redressal Committee (USGRC) constituted vide reference read 3<sup>rd</sup> as above stands re-constituted as detailed below.

1. The University Students Grievance Redresssal Committee (USGRC) is re constituted with the following members.
