#### Item No: 10S.1

Approved the proposal of the Board of Studies of the Faculty of Veterinary and Animal Sciences to reduce the tuition fee for the MSc Animal Biotechnology programme from Rs.68250/- to Rs.50,000/- per semester from 2023 admission onwards and recommended to Board of Management.

## **Decisions**

- 1. Approved the Minimum Academic Performance Requirements and Screening/ Selection Criteria of Career advancement scheme (CAS) for teachers: Promotion criteria, for Assistant Professors from Academic level 11 to Academic level 12/Selection Grade suggested as per the UGC Regulations 2018 as follows:
  - i) Overall grade for Teaching/ Administration/ other Duties should be 'Good' or 'Satisfactory' in the annual performance assessment reports of at least four of the last five years of the assessment period as provided in Annual Performance Assessment Report Table 1
  - ii) A Ph.D. Degree in the subject relevant/allied/relevant discipline.
  - iii) Attended any two of the following in the last five years of Academic Level 11

One course/ programme from among the categories of refresher courses, workshops, training, teaching—learning- evaluation technology programmes and faculty development programmes (of 10 days or above duration)

#### OR

Two courses of at least 5 days duration each

#### OR

Completed one MOOCs course (with e-certification) in the relevant subject or contribution towards the development of e content in 4-quadrant minimum of 10 modules of a course/contribution towards conduct of a MOOCs course during the period of assessment

- iv) Published three research publication in peer-reviewed or NAAS / UGC listed journals during the assessment period.
- 2. It was also decided to modify the clause for **research publication** in Minimum Academic Performance Requirement and screening/ selection criteria for promotion of teachers through CAS in all Academic levels as
  - "research publication in peer- reviewed or NAAS/UGC listed journals during the assessment period."

The Academic Council recommended to place the modified criteria to the Board of Management for final approval in this regard.

  - 6. Department of Basic Sciences and Humanities
  - 7. Department of Food Plant Operations
- B. Qualifications for Assistant Professors in the 'to be formed' departments of B. Tech. (Food Technology) and for common courses in Faculty of Dairy Science were decided as follows:

[The National Eligibility Test (NET) shall remain the minimum eligibility for appointment of Assistant Professor. Provided that candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./ Ph.D. Degree) Regulation, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor. The clearing of NET shall not be required for candidates in such disciplines for which NET has not been conducted.]
