The meeting started at 10.30 A.M. The Hon'ble Vice Chancellor welcomed all the members and the special invitees to the meeting.

The Hon'ble Vice Chancellor condoled the demise of Dr. Sajin Muhammed, MVSc scholar (2022 admission), CVAS, Pookode, Dr. P.C. James, Rtd. Professor, Veterinary Microbiology and Dr. P.S. Pushkaran, Former DE, KAU. The Hon'ble Vice Chancellor provided a concise overview of the principal endeavors undertaken by the University during the period and felicitated the students and teachers of KVASU who received various awards and medals.

The Hon'ble Vice Chancellor invited the Director of Academics and Research to present the agenda. The Council approved the minutes of the 36<sup>th</sup> Academic Council meeting of the Kerala Veterinary and Animal Sciences University with the following modifications.

1. In the subject column of item No.36. G.2 the number of Ph.D. synopsis is changed as 22 and 9 of CVAS, Mannuthy and Pookode respectively instead of 19 & 12.
2. The Item No.35. G.5 in page number 7 is a clerical mistake and it is corrected as 36.G.5.
3. The Item No. 36.H.4 was discussed. It was decided to inform the course teachers to allocate ample time during the internal exam, in accordance with the allotted marks.

The Action taken Report on the minutes of the 36<sup>th</sup> Academic Council meeting was also approved with the modifications suggested above.


