Whether the Academic Council would approve the implementation of the newly approved academic regulations and detailed syllabus of each discipline for PG and PhD programmes from Indian Council of Agricultural Research (ICAR) in the faculty of Veterinary and Animal Sciences, in Kerala Veterinary and Animal Sciences University.	The Council has approved the syllabus and decided to follow the same from 2021 admission onwards with the following recommendations made by the faculties of the Veterinary and Animal Science in the Board of Studies I.Series 500 (M.V.Sc) and 600 (Ph.D) in Clinical and paraclinical subjects shall be corrected as 600 and 700 series, respectively.


