## <u>ORDER</u>

Sri.Shibu Thimothy, Senior Farm Supervisor, AI Centre, College of Veterinary & Animal Sciences, Mannuthy & Sri.Ravichandran.U, Senior Farm Supervisor, Base Farm, Kolahalamedu (w/a at ULF&FRDS, Mannuthy) have been relieved from KVASU service on superannuation w.e.f 31.03.2025 AN on attaining age of retirement in compliance of Government Notification vide reference read as 1st above.

As per the reference read as 2nd above, University Promotion Cell (UPC) have recommended the names of officers in the cadre of Senior Farm Supervisor and Farm Supervisor Gr.I to fill up the vacancies arised due to the retirement.
