#### **COURSE DETAILS**

#### 1. B.Sc. (Hons.) in Poultry Production and Business Management

Poultry is one of the fastest growing segments of the agricultural sector in India, with an average growth rate of 8 to 10 percent per annum. Poultry Industry in India has a turnover of more than 50 thousand crore rupees per annum and is a major contributor to GDP in the Animal Husbandry sector. Poultry science education is playing a vital role in the growth of poultry sector. Presently poultry industry is lacking management professionals with adequate knowledge in poultry production. There is technical manpower shortage in various poultry and allied industries in India and in the developing countries. This degree programme was launched for moulding managerial experts having adequate knowledge in poultry production. The graduates can aspire for employment opportunities in areas such as Poultry Production, Hatchery, Feed Mill management, marketing and Poultry Processing. **This Programme also aims at supporting self-entrepreneurs who can take up their own ventures in poultry business.**

#### 2. Diploma in Dairy Science

Dairy sector contributes about 33% of the total GDP from agricultural sector. There is large requirement of trained man power in the dairy industry in India. Diploma in Dairy science is a two-year (4 semester) programme offered by KVASU and commenced 40 years back for training Dairy Farm Instructors from Kerala Government. This course covers basic aspects of Dairy husbandry, Milk processing, Dairy business management, Quality control Dairy accounting etc. Students are also undergoing practical training at different dairy farms and milk processing plants as part of the programme. Two seats of B.Tech (Dairy Technology) programme offered by KVASU is reserved for Diploma in Dairy Science holders.

#### 3. Diploma in Laboratory Techniques

A qualified laboratory technician plays a vital role in collecting the information needed, testing samples, reporting and documentation of these investigations. They provide data needed to evaluate the effectiveness of treatment. The need for a competent lab technician is inevitable in the light of emerging and reemerging diseases in animals and human beings. The course Diploma in Laboratory Techniques is being offered by the Kerala Veterinary and Animal Sciences University as a collaborative effort of three departments like Veterinary Parasitology, Veterinary Pathology

and Veterinary Public Health at College of Veterinary and Animal Sciences, Mannuthy since 2011. This is a diploma course of two-year (4 semester). Internship training for a specific period will be part of the course. In order to obtain correct results for laboratory tests, a sound theoretical and practical knowledge on laboratory practice is inevitable. Hence, the course is designed with elaborate theory classes and hands on practical of various techniques in sample examination, media and stain preparation, blood and urine analysis, assistance to necropsy and handling of microscopes and other advanced diagnostic equipments. The candidates have been specially trained to deal with laboratory diagnosis related to animal diseases. Qualified laboratory personnel will find job opportunities in the Government sector and in Private medical or biological laboratories.

#### 4. Diploma in Feed Technology

Lack of formal training programmes for feed mill operators and non-availability of qualified technical personnel for feed mill management affect not only the feed mill operations but also the availability and quality of feeds. In the present scenario, hands on training on feed technology and feed mill management are scanty in our country. The aim behind implementation of "Diploma in Feed Technology" is achieving technological innovation in animal feed production through harmonized and innovative research, providing practical guidelines, disclosing the structure and function of feed mill unit, training in feed processing and generating specialists in feed manufacturing techniques. As trained feed mill operations are scanty, trained human resource are in good demand both outside and inside the country.

#### Duration and Structure of BSc. (Hons.) in PPBM programme

It is a full-time programme. The duration of the course is maximum 4 years / 8 semesters. Each semester will be of 100 working days (excluding study holidays, examination days, and days for co-curricular and extracurricular activities)

#### Degree(s) awarded

- **UG certificate** in Poultry Production and Business Management will be awarded to students successfully completing one year/two semesters with 40 credits and 5 weeks of skill enhancement course (internship) of 4 credits.
- **UG-Diploma** in Poultry Production and Business Management will be awarded to students successfully completing two year/four semesters with 80 credits and 5 weeks of skill enhancement course (internship) of 4 credits.
- **BSc in Poultry Production and Business Management** will be awarded to the students after successful completion of three year/six semesters with 120 credits and 5 weeks of skill enhancement course (internship) of 4 credits.
- After four years of study, the student will be awarded BSc. (Hons.) in Poultry Production and Business Management.

#### **Duration and Structure of Diploma programmes**

It is a full-time programme. Minimum duration of the course is 4 semesters. Maximum duration is 8 semesters including the period of discontinuance, if any. Each semester will be of 100 working days (excluding study holidays, examination days, and days for co-curricular and extracurricular activities).

#### **Exit Point**

- Upon successful completion of one year (two semesters) of the Diploma Programme, a provision to opt a **certificate programme** after an addition of 5 weeks training involving clinical laboratory training and farm training.
- Upon successful completion of the full two-year/four semesters Diploma Programme, the student will be awarded the **Diploma in the respective subject**.

Students awaiting results can also apply. SC/ST candidates will need only a pass in the qualifying examination for the above programmes. Relaxation of 5% marks to candidates belonging to socially and educationally backward communities as defined in G.O. (p) No. 208/66/Edn. dated 02/05/1966.

#### SYSTEM OF TEACHING AND EVALUATION

Semester system of instruction and internal/external evaluation will be followed.

#### RESERVATION OF SEATS

**Types of Reservation:** Out of the total seats available for various courses, seats will be reserved for different categories under the following main items.

- 1. Special Reservation
- 2. Mandatory Reservation

#### 1. Special Reservation

#### a. Reservation of Nominees:

Three seats for the B.Sc. Poultry Production and Business Management programme are reserved for the students nominated by the Lakshadweep Administration.

The candidates under the above quota will be selected on the basis of existing rules.

**b. Reservation for Persons with Disabilities:** As per section 2 (r) of Chapter 1 of the Act, "person with benchmark disability" means a person with not less than forty percent of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. Five percent of the seats are reserved for candidates with disabilities for all courses in all colleges as stipulated in Section 32 of Chapter VI of the Rights of Persons with Disabilities Act, 2016. No reservation of seats will be available for Blind candidates. Candidates seeking admission under Persons with Disabilities category should attach a certificate of disability, issued not earlier than 12 months prior to the admission by the District Medical Board or Bodies of higher status.

**Note:** However, candidates will have to produce a physical fitness certificate showing he/she is physically fit to study the programme.

- **c.** Diploma in Poultry production holders from KVASU will be reserved two seats for B.Sc. Poultry Production programme in the total seats for the Programme. In absence of the eligible candidates, the seats will be considered as open seats.
- **d.** Children of labourers of the University farms: One seat each is reserved to the B.Sc. Poultry Production & Business Management, Diploma in Dairy Science, Diploma in Laboratory Techniques, Diploma in Feed Technology over and above the total number of seats.
- **e.** Two seats for candidates with qualifications, VHSE (LSM) or HSE (Veterinary courses in NSQF stream) to the following programmes of the University.

If no candidates are available with the above qualifications, the seats will be filled up from the General quota.

NB: The candidates seeking above mentioned special reservations, other than nominees/sponsored, should submit online application and further proceedings in accordance with the admission process.

Leaving the seats set apart for Special Reservations, the remaining seats for the above programmes will be distributed as per the mandatory reservation principle as follows:

#### **HOW TO APPLY**

All candidates, seeking admission should fill the online application form available in the University website <a href="https://application.kvasu.ac.in">https://application.kvasu.ac.in</a>. The application form in any other mode will not be accepted. Candidate must follow the instructions given in this prospectus carefully, the University will not be responsible for the defects occurred in your application.

Important things to be remembered by the candidates before filling the online application:

- The candidate must ensure that the e-mail address and Mobile number (both should be kept active till the end of application process) provided in the Online application form are their own or parents only. In some cases, the information/communication will be sent through e-mail on registered e-mail address, you should check your e-mails regularly till the completion of admission process. All the students should check the University Website regularly for updates about admission.
- The students have to submit separate applications for BSc. (Hons.) PPBM and Diploma Programmes and are advised to keep their login credentials for each course. Fill the online application carefully as further editing option is not available and note down the system generated Application Number.
- While filling the online application candidates have to upload his/ her passport size colour photograph (150W X 200H pixels) and signature (250W X 90H pixels). The size of photograph and signature shall not exceed 30 kb.
- The students have to remit their application fee through <u>State Bank Collect portal</u>, to the Educational Institution Name "KVASU- Director of Academics and Research" [State of Institution: Kerala].

- Remit the fee after registration using the system generated application number and before the submission of the online application form, since the details of fee remittance have to be entered. All candidates, except those belonging to SC/ST categories of Kerala origin, should remit Rs.1000/- and those belonging to SC/ST categories of Kerala origin should remit Rs. 500/- as application fee (excluding bank processing charges). After remitting application fee, candidate should take the print out of the fee receipt. If you had faced any problem in making payment, contact with your bank before making another payment. University will not be responsible for the duplicate payments.
- Those candidates applying for Diploma Programmes have to choose their preference of Colleges/ Courses of their interest as it has four options as given below. If the candidate is applying for both Diploma and BSc. (Hons.) PP & BM programmes, they should give their preference between these two programmes at the time of submitting application for the BSc (Hons.) PP & BM programme and they will be considered for the preferred programme, if they are eligible.

- For Diploma Programmes, options are:
  - ➤ Diploma in Dairy Science at CVAS, Mannuthy.
  - ➤ Diploma in Dairy Science at CVAS, Pookode.
  - ➤ Diploma in Laboratory Techniques at CVAS, Mannuthy.
  - ➤ Diploma in Feed Technology at CVAS, Mannuthy.
- Candidates have to upload their SSLC certificate, **academic qualification certificate showing the total marks** (**Plus two or VHSE or equivalent**) and the certificate to prove their reservation eligibility, such as Caste/ Community certificate issued by a competent authority, Non Creamy layer certificate issued by a competent authority, Income certificate issued by a competent authority (EWS category candidate must provide the model form given in the GO(Ms)No.2/2020/P&ARD of P&AR (Rules) Department dated 12-02-2020), Documents to prove the claim of special reservation (like Disability certificate or Diploma Poultry Production certificate or Certificate to prove Children of labourers of the University farms, etc). Your Certificate should be in digital form with following specifications: Maximum Size: 600Kb, Image Type: JPG

All the students are advised to keep the print out of the application form submitted online at the time of counselling and for your future reference.

#### PENALTY FOR FALSE INFORMATION

Any candidate who is found to have wilfully or otherwise given any particulars which are false or has suppressed material information or does not satisfy the requisite qualification for admission shall be disqualified. They shall not be allowed to continue on the rolls of the University, if it is detected at any stage of his/her studentship in the University.

#### **SELECTION PROCESS**

The University will publish a rank list based on the marks secured by the candidates in the Entrance Examination conducted by the University at College of Veterinary and Animal Sciences, Mannuthy, Thrissur and College of Veterinary and Animal Sciences, Pookode, Wayanad. The selection for the BSc. (Hons.) PP&BM, Diploma programmes will be done from the corresponding rank list according to the rank, options and the reservation policies persist, through offline allotment process. The students have to attend the counselling process on the date notified by the University in the rank list.

If there is a change in the selection process due to any unforeseen reasons, it will be intimated through the University website (<a href="www.kvasu.ac.in">www.kvasu.ac.in</a>). Hence, the candidates are advised to check the News and Announcements section in the University website and the application portal (<a href="https://application.kvasu.ac.in">https://application.kvasu.ac.in</a>.) regularly for updates on the selection process, if any.

#### **ENTRANCE TEST**

The candidate should download the Hall ticket (admit card/ memo) from the University website from the dates as per the schedule given. The University will not send admit

card to any candidates by post or email. Entrance examination of one hour duration consists of multiple-choice questions. Candidates will be considered for admission only if they secure a minimum of 40% marks in the entrance examination (ten percentage relaxations is given to SC/ST/PwD students).

Entrance examination will be conducted at the College of Veterinary and Animal Sciences, Mannuthy, Thrissur and College of Veterinary and Animal Sciences, Pookode. Use of mobile phones in the examination hall is strictly prohibited.

Candidates will be required to attend (at their own expense) the entrance test at the place and time to be notified. Candidates reporting after commencement of the examination will not be permitted to write the examination. Similarly, candidates will not be allowed to leave the examination hall in the middle of the examination.

#### ANNOUNCEMENT OF RESULTS

The provisional rank list of the candidates eligible for the admission to all programmes will be published in the University website. The candidates are admitted from the rank list according to the rank and communal reservation. No separate intimation letters will be sent to the qualified candidates.

#### **ADMISSION**

Admission to the programmes conducted by the University is done through offline allotment process from the rank list published in the University website after conducting the entrance examination. To complete the admission process students must report at the Colleges with all the original certificates along with the xerox copies and the receipt of remittance of the fee for first semester, mentioned in the rank list/allotment memo published.

If the selected candidates fail to pay the specified fees or join the course in time, their claim for admission will be cancelled without notice and the seat thus becoming vacant will be filled up with eligible candidates, if any, from the rank list.

Candidates should produce the **original certificates** for **proof of age**, **qualifications**, **transfer certificate**, **conduct certificate**, **migration certificate**, **Non Creamy layer/ Community certificate** if seeking communal reservation, **Income and Assets Certificate**, annexed in the G.O. (P)No.1/2020/P&ARD dated 03/01/2020, for claiming the reservation of Economically Weaker Sections (EWSs) in General Category, **Disability Certificate** for claiming reservation under Persons with Disability, **Physical fitness certificate** obtained from any Medical Officer not below the rank of Civil Surgeon, **Vaccination certificate** against Chicken pox and Hepatitis B **at the time of admission** in the respective colleges. Candidates who secured their qualification from Universities/ Boards outside Kerala state should produce Migration Certificate. If you are not able to submit a migration certificate at the time of admission, you should produce an affidavit (in your own handwriting with signature), stating that you will produce Migration Certificate within one month after securing admission. Vaccination certificate against Chicken pox and Hepatitis B is

compulsory at the time of admission for all courses under KVASU.

The originals of all certificates and documents should be produced at the time of admission. Those who do not produce the original documents at the time of admission, shall forfeit their seat and the seats will be filled from the waiting list or in any other manner deemed fit by the University.

As ordered in G.O. MS 285/72/HD dated 6.1.1972, 10% of the total intake capacity will be reserved for SC/ST. Fractions of half or more than half in the actual working out of the percentage will be rounded off to one. List of communities to be considered under SC/ST/OEC will be as per the list approved by the Government of Kerala.

#### **EXEMPTION FROM PAYMENT OF FEES**

The candidates belonging to Scheduled Caste, Scheduled Tribe and Other Eligible Communities of Kerala origin have relaxation of fees as per the Government directions. However, these candidates have to remit the admission fee and College caution deposit at the time of admission. The eligible students should submit the caste/community certificate to prove their claim for exemption at the time of submission of online application form and at the time of physical reporting. If the candidate is failed to produce the caste/community certificate to prove their claim should have to remit the complete fee for the first semester. The High Court of Kerala will be the only judicial body to decide on the disputes arising if any, in the matter of admissions.

#### **HOSTEL FACILITIES**

Hostel facilities will only be provided on availability in the respective campus. Those who do not secure Hostel accommodation within the campus shall make their own arrangements outside. Students admitted will not have any claim for hostel facilities in any of the campuses and the university does not undertake to provide such facility by way of this prospectus.

NOTE: B.Sc. (Poultry Production and Business Management) programme, Diploma programmes offered by the University are purely intended for imparting knowledge and skill developments in the field of veterinary and animal sciences and the University do not assure/guarantee any Government job for these programmes.

WARNING: Ragging is totally prohibited in the campus and all the students shall observe and abide by the rules & UGC regulations on curbing the menace of ragging in higher educational

institutions 2009, under Section 26(1) (g) of the University Grant Commission Act 1956 dated 17.06.2009 published in the Gazette of India part-III, Section 4. Any student found guilty of ragging and/or abetting ragging, whether actively or passively or bearing a part of a conspiracy to promote ragging is liable to be punished in accordance with the foresaid regulations.
