- 3. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs.200 (Rupees Two Hundred only) in the prescribed format that can be downloaded from the website www.kvasu.ac.in
- 4. The sealed cover containing the tender documents should be super scribed "Tender for Supply of Vitamin Premix" at Revolving fund Poultry Project- Feedmill, Avian Research Station, Thiruvazhamkunnu. The cover should contain the DDs for tender cost and EMD.
- 5. The successful tenderer should execute an agreement as prescribed by the University in the Kerala Stamp Paper worth Rs. 200/- and furnish a security deposit @ 5% of the cost of items quoted by them in the form of Term Deposit/Bank guarantee/DD drawn in favour of the, The Special Officer & PI, Revolving Fund Poultry Project, Avian Research Station, Thiruvazhamkunnu 678 601, Palakkad District payable at the State Bank of India, Alanallur (IFSC: SBIN0070939). The security deposit shall be refunded after the expiry of the contract period.
- 6. The rate quoted, tax and other charges if any, should be separately stated. Rate quoted should be include all expenses up to delivery in the premix store room.
- 7. The Special Officer & PI has the right to accept or reject any or all of the offers without assigning any reason.
- 8. The successful tenderer shall initiate the supply of the item within one week of award as per demand.
- 9. If any Hartal/strike/any unexpected holiday occurs on the date of opening of tender, the tender will be opened at the same time on the next working day.

- 11. All the items must be delivered (including unloading) at the storage house of Revolving Fund Poultry Project-Feedmill, Avian Research Station, Thiruvazhamkunnu.
