I. COMPANY/DEPARTMENT PROFILE:

The Kerala Livestock Development Board originated in 1976 from the merger of the Indo Swiss Project Kerala and the Bull Station Dhoni under the Dairy Development Department. The body formed that year was later divided in 1983 into the Kerala Co operative Milk Marketing Federation and the Kerala Livestock Development Board, with KLDB becoming a fully government owned company.

II. JOB DESCRIPTION AND RESPONSIBILITIES:

The Managing Director is the Chief Executive of the Company and accountable to the Board of Directors / Government / Shareholders. He/She is responsible for the efficient functioning of the Company, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY:

1. QUALIFICATION:

1) Degree in Veterinary and Animal Science from a recognized University 2) MVSc in Animal Genetics & Breeding/Animal Reproduction/Biotechnology from a recognized University.

2. AGE LIMIT:

Age between 45 and 62 years as on the date of Notification.

3. EXPERIENCE:

Minimum 25 years' of experience in a PSU in the fields of Frozen Semen Technology, Animal Breeding, Bull Mother Farm Management and out of which minimum 5 years of service in the capacity of General Manager.

4. SKILLS:

Working knowledge in Malayalam.

5. REGISTRATION/CERTIFICATES:

Registration with Kerala Veterinary Council as envisaged in the Indian Veterinary Council Act 1984 (Central Act 52 of 1984)
