4	Brief Description of Work	The proposed works include maintenance activities in the NLM Laboratory, Old HPLC Room, Proximate Room sunshade, and Biomaterial Laboratory. The scope of work comprises painting, rectification of water leakage, and other essential repair and maintenance works. In addition, gypsum paneling is proposed for the Biomaterial Laboratory, and a rack shelf is provided in the Biomaterial Laboratory/HPLC area as per the site requirements. Electrical estimate has been prepared based on a site inspection for the conversion of the existing surface conduit wiring to concealed conduit wiring the Biomaterial Lab. The scope of work also includes the replacement of the existing ceiling fans with three wall-mounted fans. Appendix 2 estimate is prepared based on the damaged wall with necessary provision including providing steel tubular works ,plastering ,painting etc.The Head of department also requested to repair the drain inside carcass shed and necessary provisions for providing RCC drain for length of 24m have been included.
